Dear Mssrs. Milan and **Bertram**:

In response to your telephone call of January 15, 1998 with respect to the confidential documents we submitted in the captioned docket on December 23, 1997, we are enclosing the following:

(1) An index that relates each document (by Bates number) to the information request number (as set forth in pp. 44-64 of the joint application); and

(2) More legible copies of 380-403 and 420 (and, where necessary for readability, a transcription of the data contained in these documents). Please note that the traces of illegible writing at the bottom of 380 and 381 appear to be ink which bled through from the reverse side. The only documents we located were copies of those pages, so we do not have any legible source for the writing on the back. We are providing three copies of this material in a sealed envelope. We are also providing three copies of 127-132, which were not included in our original submission due to a duplicating error. All of these documents are protected from public disclosure by our motion for confidential treatment under 14 CFR 302.39 filed on December 23, 1997.

In your call, you also asked for an explanation of why 375, 376, and 377 are almost entirely blank. These are file folder headers, and do not contain any more information than is shown.

Finally, you indicated an interest in reviewing the pages in the American/Lan Chile agreements on which we have made redactions, and said that you would let us know when you want us to bring the original, unredacted pages to your office for such review. We are ready to do so at your earliest convenience.
