
MOTION OF AMERICAN AIRLINES, INC. FOR

This motion supplements the joint motion for confidential treatment submitted by American and Swiss International Air Lines Ltd. d/b/a Swiss in this docket on June 28, 2002, in connection with their joint application for antitrust immunity. American is submitting additional confidential documents as identified and described in the attached supplemental index. We request that access to these documents be limited to counsel and outside experts for interested parties.
